- Call to Order Jesse called the meeting to order.
- Quorum A quorum was established. 9 persons were in attendance via Zoom.
- Treasurer's Report
 - The financial report will be emailed as soon as we receive the information from the accountant's office; they are running late due to the tax filing deadline.
- Committee Reports
 - Membership
 - Currently we have 283memberships; we need approximately 325 members to break-even with the planned annual budget.
 - We expect a \$7500 budget shortfall by end of the fiscal year.
 - We have reduced the pool membership price to \$285 for new members joining this late in the season, and may reduce it further for the rest of the season.

o Pool

- The board discussed how long we should stay open. Typically, we close full-time mid-August and stay open only on weekends through Labor Day weekend.
- The board decided that Friday, August 14th will be the last weekday that the pool will be open; the pool will remain open on weekends through Labor Day.
- The board voted to host the Dutch Fork High School swim team with social distancing restrictions, assuming that the high school 10-week season will proceed this year.
- We will be charging Dutch Fork \$300/week for use of the pool, plus \$100/week for additional cleaning due to COVID-19.
- Swim Team
 - The team is wrapping up their season.
 - The league heled a virtual city meet, and Murraywood finished in 2nd place.

- The season ran as smoothly as could be expected.
- A socially distanced team photo was taken via a drone.

o Tennis

- The Ray Sansbury dedication is scheduled for 6:30 PM on August 14th.
- We are expecting donors and family members to attend.
- Jeannine took the action to reserve courts 7 and 8 for the event so that attendees can socially distance.

Maintenance

- There is a tree that needs to be removed in the pool area near the back fence; Jesse has a quote for \$600 that is still in negotiation. Jesse took the action to get another quote so that we can expedite the removal before the tree damages property.
- Jeannie took the action to check out the lights on the courts in preparation for the combo season.
- Phil and Tommy fixed the sprinkler on court 5.
- One the neighbors noticed teenagers trespassing (most likely to enter the pool), and called the police. Katherine took the action to provide a guest pool pass to that person as a thank-you.
