- Call to Order Jesse called the meeting to order.
- Quorum A quorum was established. 11 persons were in attendance via Zoom.
- Treasurer's Report
  - Carol reviewed the financials through August 2020, with projections for the remainder of the fiscal year.
  - Our accountant is planning to review our assets to determine if there are any assets that we can write off prior to taxes.
  - Carol supplied gross sales and payroll estimate to Sandra for updates to our insurance for the next year. Meredith is working on the asset replacement information for Sandra, and Paige is sending requested pool numbers to Sandra.
  - Based on current projections, we expect to finish the year with approximately \$10,000 cash on hand, reflecting about \$15,000 loss for the year. (This does not include anticipated expenses for the courts 5 &6 lights.)
- Committee Reports
  - o Tennis
    - Richard Longphre has requested that morning court reservations remain at 9 and 11 to allow at least 2 opportunities for play each morning, and change league times from 9:30 AM to 9:00 AM. As we cannot control USTA League match times, Jeannie will send a request to Joyce, the league coordinator.
    - There is also concern that parents are reserving clay courts for juniors to play on Saturday mornings, taking the courts away from working adults. Jeannie and Will took the action to meet with the parent group to work out an amenable solution.
    - We have received quotes from Love Electric for replacing the lights on court 6. Unfortunately, Love has quoted a higher price to install the lights we have already purchased than to purchase lights (of less lumens) from them and install those.

- Jesse has the action to convene a sub-committed to obtain quotes from other vendor(s) and evaluate the options.
- o Pool
  - The pool closed on Labor Day, as planned.
- o Maintenance
  - One of the court 8 lights is out; Phil will investigate.
- Old Business
  - Court Benches in Cam Littlejohn's Memory
    - At the previous board meeting, Jeannie suggested that the club should honor Cam Littlejohn's memory in some way.
    - As the club voted to use the profits from the spaghetti supper for new benches on the tennis courts, the same that Scott built for us on court 5.
    - The board recommended that we could raise money to add plaques to the benches to dedicate to Cam's memory.
    - Jennie has the action to send out a letter requesting donations for a memorial for Cam.
    - Several people have expressed interest in purchasing and assembling the bench kits. The bench kits average \$70 per bench; Sandra is working on getting the wood donated.
