- Call to Order Mary Ann called the meeting to order.
- Quorum A quorum was established. 10 persons were in attendance via Zoom.
- Insurance Review
 - o Sandra reviewed the updated insurance policy.
 - Once again, thank-you to Sandra for keeping our costs as low as possible. The total for our policy this year is \$13,974.18.
 - Action Carol and Meredith will review the payment options and determine whether we should pay the entire premium at once or finance it over the course of the year.
 - The board agreed that we should post private property no trespassing signs on the field near the parking lot.
 - **Action** Barbara to work with Alex Paris to procure the signs.

• Treasurer's Report

- o Carol reviewed the financials through September 2020, with projections for the remainder of the fiscal year.
- O Current projection is to end the fiscal year with \$13,500; there is a possibility of an additional \$2000 refund of taxes. Anyone who would like more in-depth information regarding Murraywood's financial status should please contact a board member.
- o Carol got our accountant, Robert Muller, to lower monthly rate from \$145 to \$125.
- o Carol confirmed with Robert Muller, CPA, that despite Murraywood's Secretary of State filings, we are a "for profit corporation for IRS and SC tax filings".
- We are exploring lower cost alternatives to SAGE accounting software. Quickbooks is a cheaper option, and Carol will research their products with the goal to replace SAGE in 2021.. Meredith suggested that we start the new package in 2020 and then transition from SAGE in January.
- Rita recommended that we explore a web-based (cloud) option rather than software that is installed directly on a specific PC to avoid security/privacy risks.

- Action: Carol to research Quickbook products and the possibility of pro-rated refund on Sage.
- The board also decided to maintain the internet service and refund Anne and Sean who offered and paid for the continued service.
- Action: Carol and/or Meredith will check on lower rates for internet with other companies.

• Committee Reports

- Membership
 - Katherine reported that we have 3 new families join as tennis memberships in the last month.
 - Pool
 - Paige reported that the swim season, including the high school season, is officially finished for 2020. We are now back to off-season operations.

o Tennis

- Jeannie shared with the board the contract for tennis maintenance and announced that Tommy plans to resign the position. Please help pass the word to persons who may be interested.
- Many thanks to Phil Watson, Tom Keckeisen, and Ken Bogan for installing the new benches on the courts. Thank-you also to those who donated for the purchase of the benches. Several ladies have volunteered to stain the benches once they dry completely.
- Jeannie has convened a committee to work on an appropriate memorial for Cam. We have received \$2740 in donations designated for the memorial. One consideration is a walkway to courts 5 and 6.

Maintenance

■ Jeannie reported that Jesse's committee has gotten a 2nd quote to resolve the electrical issue with court 6 lights. We will also have to replace lights on court 2 and court 8. The board voted to spend up to \$3500 on repairing/replacing lights for the 3 courts.

- Due to COVID, we do not plan to hold a Christmas gathering this year, although the committee will decorate the grounds for Christmas.
- Carol recommended that we plan a food drive or arrange an online donation to a local foodbank, such as Sharing God's Love or Harvest Hope.
