- Call to Order Jesse called the meeting to order.
- Quorum 8 board members were present; Carol Paulson voted remotely.
- June minutes were approved via email; Rita to resend to include edit from Carol.
- Treasurer's Report
  - Carol will send updated financials for June shortly.
  - We discussed issues with Sage and the delay in payroll checks for lifeguards.
  - Although we had decided at the previous meeting to purchase a laptop to be dedicated to financials, either for Quickbook or another program to replace Sage, we would like to price a cloud based alternative.
  - Action: Kathi to research cheaper alternatives to Sage or Quickbooks.
- Committee Reports
  - o Membership
    - Currently, we have 196 total memberships. 239 pool memberships, 62 full facility memberships, and 48 tennis ony.
    - Membership revenue for the year is projected to be about \$25,000 over the amount budgeted.
    - We decide not to offer a lower rate for pool members who join after July 4<sup>th</sup> this year.
  - o Social
    - Katherine is making plans for a Fall bunko night.
    - The club would like to host another pool movie night.
    - Food trucks were discussed at the June meeting; after checking with several vendors, we have concluded that we do not offer enough guaranteed business for

any vendor at this time. Perhaps, we can revisit next year for swim meet nights and other highly attended times.

- o Tennis
  - Many thanks for Phil, Tom, and Mike for cleaning up the area around the practice wall. The board voted to compensate Mike for the additional work contributed.
  - We expect to receive 2 quotes from Howard B. Jones to refurbish all 4 clay courts or just 7 and 8. Please note that courts 5 and 6 were re-done after the 2015 flood.
- o Pool
  - Swim lessons are booming.
  - Concessions are also doing well.
  - Guests we do have a family that has now hit their limit on attending as visitors. The board approved offering pool memberships, on a case by case basis, to frequent visitors at the going rate and crediting them the amount spent for visitor fees.
- o Swim Team
  - Swim team season is coming to a close; the last meet is this Thursday against Governor's Grant.
  - Monday will be the end-of-season celebration.
  - A total of 162 swimmers participated this year.
  - There was some concern over a child during the last meet who was having difficulty completing the race, and how the situation was handled; Jesse is meeting with the concerned parent.
- o Clubhouse/Facilities Improvements
  - Restroom Upgrade- The pool doors are now working; the only item remaining to open the pool restrooms outside pool operations hours is the procedures for managing the access
  - Kathi is heading up an exploratory committee to invest in additional pickle ball courts and restoring the clubhouse.

## o Maintenance

- Drainage and Court 1
  - No update yet on court 1; the drainage repair is on the Lexington County agenda for the next meeting.
- One of the lights on court 7 is out.
- Locks on the lights are done. There was some issue with some of the keys not working. Action: Kathi took the action to have Irmo Lock resolve.
- Decking
  - Sandra reported that Columbus Lumber is donating 3 2x6x10 bundles and 1 2x6x8.
  - We will need to schedule pick up of the lumber soon.

- Both Scott Johnson and Patrick Hanks have trucks; we will need volunteers to assist in loading and unloading.
